2.0 INTRODUCTION

The meeting started at 12: 53pm with an opening prayer by one of the representatives of Mantrac Nig. Ltd (Mr. Babatunde). The Centre Director welcomed the general public that attended the meeting. He stated that the meeting was called to open the financial bids of the successful bidders, i.e. the contractors who passed the Technical Evaluation stage while the financial bids of those contractors who failed the Technical Evaluation would be returned unopened. He said the objective of the evaluation focused on the documents submitted by the Contractors and the eligibility criteria published in the National dailies.

Based on the above information, the bids of the unsuccessful bidders were returned immediately. However, the Chairman pleaded with them to stay in the room to observe the process of financial bid opening. The representative of Megastructure Tech. Nigeria Ltd. asked why the Sworn Affidavit submitted was not accepted by the Technical Evaluation Committee. The Chairman responded that the Sworn Affidavit was not recent but expired and could not be used to assess the current bid.
